

GLOBAL JUSTICE: PRINCIPLES & PRACTICE

This course studies the principles and practice of global justice. The course reviews both biblical principles and human rights standards of justice and its application to a range of international political, civil, economic, social, and cultural justice issues. The course also reviews key institutions -- governmental, intergovernmental, and nongovernmental--that address global injustices and international policies. In addition, the course discusses the role of individuals and communities in the pursuit of biblical justice.

GLOBAL ADVOCACY & LEADERSHIP

This course studies the principles and practices of global advocacy and leadership. The course reviews both biblical principles and leadership standards of advocacy on a range of international political, civil, economic, social, and cultural justice issues. The course also reviews key institutions governmental, intergovernmental, and non-governmental--that address global injustices and international policies. In addition, the course discusses nonprofit management and related leadership best practices for effective advocacy in nongovernmental, governmental, and other organizations.
